Q3. Is there an administration building going to be included?

Per Section 2 — Evaluation of Qualifications, Item 2.c on page 9 of 37, which reads, "A person is not eligible to be considered for award of this solicitation or any resulting contract or to be a subcontractor of the proposer or prime contractor if the person assisted in the development of this solicitation or any part of this solicitation or if the person participated in a project related to this solicitation when such participation would give the person special knowledge that would give that person or a prime contractor an unfair advantage over other proposers." Please confirm if the firms that assisted in the development of the Programming document, video and renderings for this project are either eligible or ineligible from pursuing the design services for this project. Additionally, please confirm and share the names of the firms that helped develop the Programming documentation for this project.
